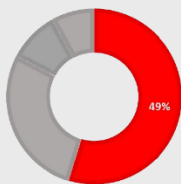

Omoha Nduka John commonly known as Prince Omoha is a Nigerian Real Estate Entrepreneur, Investor, and Philanthropist.

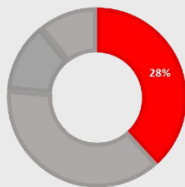

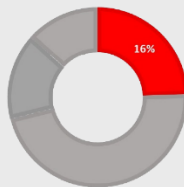

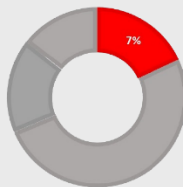
REAL ESTATE AND
CONSTRUCTION – 49%



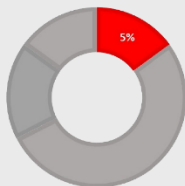
STOCKS – 28%
